External auditor report (ACKE0058)

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- The smaller authority has not approved the Annual Return in accordance with the Accounts and Audit Regulations 2015, since the approval of Section 1 took place prior to the year end on 7 December 2015.
- The Annual Return has not been signed in accordance with the Accounts and Audit Regulations 2015 as Section 2 was not signed by the Responsible Finance Officer before approval (approval date 9 May 2015, RFO signature 4 June 2016).

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

- The Internal Auditor has responded 'no' to Box B of the Annual Internal Audit Report; however, the clerk has provided evidence to further explain the matter under discussion.
- The Internal Auditor has responded 'not covered' to Box H of the Annual Internal Audit Report. The balance for shown in Section 2 Box 9 for 2015/16 is £609 240 but no explanation has been provided for the Internal Auditor's response.
- Any amendments made in Section 2 of the Annual Return must be initialled and dated by the RFO/Chairman.
