- 76. Apologies and Absences Cllr Dalton & Cllr Eastwood
- 77. Declarations of interest or lobbying None declared
- **78. Minutes of Previous Meeting** The minutes of the meeting on 12-6-17 were agreed and signed by the Chairman

79. Questions from the Public

- a) The painting of the kerb by the school was raised. A price is awaited from Marchants to provide a tin of paint
- b) The state of Chevening Road surface and also the state of the verges was raised as a concern. As these are issues dealt with by KCC these should be directed towards our KCC Councillor Nick Chard.
- 80. Open Spaces
- a) Open Space Inspection
- b) Playground Inspection
- c) Renovation of benches report from Chairman & Cllr Branton
- d) Bike Rack at Sailing Club Road. The Chairman is still awaiting a response from SDC as to whether this requires planning permission. Cllr Ide does not believe planning permission is required under Local Development legislation but the Council felt it was best to obtain formal agreement from SDC. Cllr London offered his support if there were issues with gaining a response. The Council debated the options for planters beside the bike racks and whether to spend an additional £400 having substantial planters made from railway sleepers which could not easily be damaged by cars. It was resolved 4/3 to spend £1110 on installation which includes the more substantial planters. Clerk to investigate whether it would be possible to use CIL money for this.

e) **Holmesdale Anglers** - Chris Becker, Chairman of the Anglers addressed the Council with his request for an Annual grant of £4000 in return for Social membership of the Club for all Parishioners. The Council was unclear as to precisely what benefit would be derived from this membership, including the

scope of the footpaths behind the Sailing Club and whether membership would grant permission to walk the North shore. Mr Becker will produce a plan confirming exactly which footpaths and which lakes are covered under the proposal and suggest dates to the Clerk for a working party of Councillors to walk the area and see what areas would be included and therefore the benefit to the Parish

f) Dog mess on the paths around the Lake Cllr Dalton raised concerns over the amount of mess which has worsened in recent weeks. It was resolved to purchase warning signs (including potential fine) to be put up on the metal railing around the weir and near the playground

- **81.** Providing cycle safety training for local Children The Chairman reported he was unable to get any availability from KCC who organise the cycle training. He has provided the school with details of training taking place over the summer in Tonbridge
- **82. Parish Survey.** Cllr Burgess volunteered to lead the work on updating feedback from the community as to what they wanted from the Council. Cllr Burgess confirm she was not looking to maildrop every house as was undertaken in the Parish Plan, but to use other media to achieve the same ends. It was resolved to update as part of the 2017 Annual Report to the Parish.
- **83. PC flood subcommittee** Mick Ryan addressed the Council with the concerns of the Flood Committee and the lack of response from KCC. The amount of work undertaken by KCC clearing the streams at Brasted/Sundridge will mean that as a result the water from there will flow much more quickly into Chipstead. There is extensive email evidence of the issue being raised with KCC should flooding occur but in addition Mick Ryan to ensure Nick Chard is made aware of the issues
- 84. Chevening Mailer The Council debated whether the Chevening Email Newsletter should remain independent or whether it should be covered under the Parish Council's insurance and therefore "supported" by the PC. The Council was clear it did not want editorial review of the newsletter and was unanimous in the support of the newsletter and the work it does. The Council voted 5:2 to have the Mailer being independent with Cllrs Dilley and Weavers voting against.
- **85. Highways** The 20 mph limit has a confirmed installation date of 31st July. KCC will be going out beforehand to ensure the signs are in the correct place. Clerk will let the Speedwatch team know the date when this is happening. The A21/A25/Homedean Road junction is one of the top 5 accident sites in Kent. The design work is booked for this summer although it may not go ahead if funds for the actual work cannot be found.
- 86. Correspondence Received and General Issues
- a) Request for a playground in Bessels Green. The Council resolved that it would not be safe to build a play park on Bessels Green. If a park was built on Chipstead Common the neighbours most affected would be in Riverhead Parish. Chairman to write to Chair of Riverhead PC to gauge their views.
- b) **Football on Chipstead Common** Chipstead FC are taking over from Riverhead Angels the use of Chipstead Common. They additionally wished to use the

- ground for training on a Tuesday night. The council resolved that for the first year Chipstead should take the ground on the same terms and payment as Riverhead Angels, i.e. for Sunday matches only.
- c) Lifting tree crowns on Chipstead Common A quote has been obtained as indication of the costs involved. The Council resolved to commission the work, together with clearing the overgrowth round the Football Hut for a maximum spend of £650.

87. General Information and proposals for Future Agenda Items

- a) **Bus services** The issue of the cancelled bus service was debated. Where bus services are provided initially by KCC once the subsidy money ends the Bus Companies remove the service. There are also examples of more than one company operating the same routes at the same time when subsidised. The District Council is pursuing the removal of bus services but there has not been any significant reaction from Parishioners at the loss of the service
- b) **Youth Services Provision** KCC will be running 2 workshops at Chipstead Recreation Ground on 29th August. This will be free to young people and will be a drama workshop in the morning and circus skills in the afternoon
- c) Arts & Crafts Fair it was resolved that the Council would not rent it's green spaces for an Arts & Crafts Fair in 2018
- d) **Open Spaces Tender** 4 companies (including MDH) have been approached and expressed interest in tendering for the Open Spaces maintenance business

88. Finance

- a) Income Received and Cheques Payable —the payments for July were resolved and signed by the Chairman and Vice Chairman & the payments and receipts for June were reviewed Appendix 1.
- b) The income and expenditure for quarter ended 30-6-17 was reviewed
- It was resolved to pay any outstanding invoices for August (payments due from July 2017) by email circulation of the details and formal resolution at September meeting
