- 123. Declarations of interest or lobbying None
- **124. Minutes of Previous Meeting** The minutes were resolved unanimously and signed by the Chairman
- 125. Questions from the Public None
- 126. Open Spaces
- a) Open Spaces Inspection It was agreed a working party of the Chairman, Cllrs Dilley, de Turbeville & Weavers would carry out "topple testing" at the Churchyard and Burial Ground
- b) Playground Nothing to report
- c) Sailing Club Road The Chairman confirmed Andy Hogg would donate £2000 towards the repairs. It was resolved to engage Marchants to repair the river side of Sailing Club Road (Option 2 (c) and for the Council to use their CIL money for their contribution. In addition Marchants will be asked to complete the patching of potholes and additional repairs (Their Estimate 2) costs of those repairs should be shared between Sailing Club, Cheshire Home, Anglers and Parish. Repairs to be undertaken asap. Cllr Weavers asked whether we should consider removing the shrubs between the parking bays on the lake side. It was resolved to investigate that as a separate project as it may require planning permission
- d) Fencing off open space in Chesterfield Drive The Council confirmed it's position that fencing the open area in Chesterfield Drive was not a good use of resources. There are other open spaces in the Parish which may be a greater risk from an Unauthorised encampment
- e) **Football Club & Drainage** Cllr Branton expressed concern over the dips in the pitch. The Council resolved to express it's concerns about the danger posed by the ruts in the pitch to the Football Club to ensure the referee passes the pitch as safe to play before each match. Cllr Branton confirmed the drainage appears to be working and the foul language heard at some matches was much improved. The Council resolved

- the spend of £416 for worm treatment and fertilizer for the Recreation Ground leaving a balance of £154 of agreed maintenance spend for 2016/7
- f) Chipstead Common The Council resolved that there was no objection to the goalkeeping training as it is only three hours once a week. Clerk to investigate whether they need to make a payment

- g) **Open spaces tender** The review of tender document was deferred until December meeting
- h) Circular bench on Chipstead Green Chairman identified a metal circular bench to go round the Chipstead sign on the Green which Andy Hogg has said he would pay for.

 The Council resolved that the family of Esme Witton & Donald Calvert (who want to put a memorial bench on the green) and Andy Hogg should get together to investigate funding a wooden (oak) bench.
- i) **Chevening Churchyard gates** a revised quote for the Churchyard gates and replacing Clerk 1 post for the single gate to the garages will be presented to the December meeting

- a) Response from KCC concerning the "Roundabout" The article referred to in the Parish newsletter is from Roadworks.org website. It is a forward planning notice to ensure we can book the road space if the scheme is progressed. No detailed planning or funding has been undertaken
- b) Update on 20 mph through the village. Total cost of the scheme will be £5,509.68. The Council resolved to proceed with the implementation of the limit
