79 Apologies and Absences

Apologies for absence were received from Cllr Eastwood and duly accepted by the Chairman. Cllr Robinson from SDC also sent her apologies

80 Declarations of interest or lobbying

There were no declarations any interests or lobbying regarding items on this agenda

81 Minutes of Previous Meeting

The minutes of the meeting on 9th May 2023 previously agreed by email were resolved by the Council and signed by the Chairman as a true record

82 Updates from KCC.

Cllr Chard did not attend the meeting

83 Updates from SDC

Councillor Alger updated the Council and the members of the public present as to the key roles in SDC following the elections in May, including Leader of the Council and Portfolio Holder positions for cabinet. There were no specific questions from the public for ClIr Alger

84 Questions from the Public

A member of the public expressed disappointment that Cllr Chard was not present as his question related to KCC Highways. He requested that KCC consider putting width restrictions near Rivermere to discourage the HGVs which ignore the width restriction signs and continue to try and come through Chipstead. He confirmed that an HGV had gone through Chipstead around 5 a.m. that day. The Chairman confirmed that in his SDC capacity he sits on the JTB (Joint Transportation Board) and he would raise and progress it through that meeting

85 Open Spaces

The Council discuss recent correspondence from a Parishioner concerned about the state of Sailing Club Road. The Clerk confirmed there are issues with all the "popular" rubbish bins (Bessels Green, Chipstead Common Chipstead Green and Sailing Club Road) as she regularly picks up rubbish to put back into the very full bins. The rubbish is pulled out by birds &/or foxes overnight as it is a regular occurrence on Friday and Monday morning. The bins are emptied Monday, Wednesday and Friday. The Council debated whether there was anything more which could be done and regrettably there is little as the incidents are not in CCTV range and there is no desire for lighting down there to act as a deterrent

a) Open Space Inspection

Cllr Jarrett commented that 2 posts on Chipstead Common had been knocked, presumably by cars parked there and were no longer upright

Cllr Jarrett also asked about the sign at the Recreation ground warning that there were rats in some nearby houses. The Clerk confirmed that an email had been received signed off by the residents of the houses in question to warn of the potential infection risk for children playing in the stream. The Council agreed that unfortunately, wherever you live rats are very close by

Cllr Alger asked whether the Parish Council could cut the hedge on Chipstead Green as this was obscuring the view of the lake from the green. It was confirmed the hedge concerned is not on Parish Council land but the Clerk will enquire of the Angling Club whether they will allow the hedge to be trimmed

b) Playground Inspection

There are no reported issues with the Playground. The Annual Safety inspection takes place in July

86 Postal Services

Cllr de Turberville & Cllr Eastwood raised concerns the Post Office is failing in it's Universal Service Obligation and Parishioners have reported almost missing important appointments notified by post because of the sporadic nature of the deliveries. The Council agreed this was a nationwide issue but the Chairman will raise the matter with Laura Trott so that she can escalate the problem with her Parliamentary colleagues.

87 Concern raised about a tree in Sailing Club Road and reeds in the river

A resident had expressed concerns about a large alder tree in Sailing Club Road and the amount of reeds in the Parish Council side of the river. The Clerk confirmed she had had an inspection carried out on the tree as the Parishioner was concerned the tree was leaning further and further towards their property. The Inspection did not find there were any issues with the tree

The Clerk stated that Holmesdale Anglers had been very helpful over the past few weeks and months over a number of issues. Under a previous Chair and during lockdown the relationship was more strained but the Clerk advised they have helped with both offering to inspect the Council's stretch of the river and report back, and also promising to deal with the knotweed, which is present on Council land overlooking the lake at Chesterfield Drive once again.

Once the report from the Anglers has been received (with recommendations) the Clerk will share with the Council and subject to actions agreed with the Parishioner concerned

88 Proposed 40th Birthday party on Chipstead Green

The Applicant withdrew the request after the agenda was published but before the meeting because of her concerns about upsetting the neighbours. The item was not debated.

89 Bus shelter on Chipstead Lane

The Council debated whether to move the bus shelter on Chipstead Lane to Chipstead Corner but decided to leave the existing shelter in place and look to source a new shelter. The Clerk was instructed to enquire whether grants were available from KCC and to look for alternative suppliers to get price comparisons for the next meeting

90 Posts on Chipstead Green.

The posts on Chipstead Green are very old and irregular and the Council instructed the Clerk to price replacing the posts given that the presence of the planters means there are less needed to protect the Green from any incursion

91 Correspondence Received and General Issues

The Council discussed the Annual Parish picnic. The proposal is to hold around end June (mid summer) from 2024 onwards. The Council debated having tables to hire and a marquee. It was felt that should it be raining people simply would not come but that having table is a good idea.
