- **126. Apologies and Absences** apologies for absence were received from Cllr A Clark, Cllr Dilley and Cllr Weavers
- **127. Declarations of interest or lobbying** Cllr Ide raised a personal interest in item 135 a) as she is already a member of the Friends of Rhienbach and therefore did not take part in the vote.
- **128. Minutes of Previous Meeting** the minutes of the meeting on 10-9-18 were resolved by the Council as a true record and duly signed by the Vice-Chairman
- 129. Questions from the Public No questions were raised

130. Open Spaces

- a) Open Space Inspection
 - i. Cllr Branton raised the hedge on Homedean Road. The hedge has been cut on the sides but not the top which looks untidy and is not blocking the view from Homedean Court
 - KCC Highways need to address the cobbles in the High St which are still very uneven in places.
- b) Playground Inspection Nothing to report
- **131. ID Badges for Councillors.** It was resolved to provide ID badges for all Parish Councillors and the Clerk at a cost of £5 each. They should have a unique id number on them.
- **132. Decaying Ash Tree on Chipstead Rec** It was resolved to replace the decaying ash tree with a field maple in a suitable position near to the felled tree.
- **133. Sandbag storage at the Recreation Ground** The Council resolved a maximum spend of £500 to build storage for sandbags at the car park end of the building. If the estimate is higher than that the Clerk will bring the proposal back to the next meeting for resolution
- 134. First World War Commemorations & War Memorial

- a. Cllr de Turberville presented before and after photographs of the War Memorial and the Council were delighted with the outcome. The cost of renovation was £4740 plus £350 for scaffolding total £5090. The War Memorials Trust gave a grant for £3020 therefore the cost to the Council will be £2070.
- b. The Beacon of Light ceremony will take place on Sunday 11th November at 6.45 pm on Chipstead Green. The Beacon has been ordered, a bugler is being sourced. It was suggested to invite the Foreign Secretary to light the Beacon should he be at Chevening House that weekend. Cllr de Turberville will make enquiries.

135. Correspondence Received and General Issues

a) The Council discussed the merits of the Friends of Rheinbach. The Council felt there was negligible value to the Parish of the Friends of Rhienbach and therefore declined to donate at this time

136. General Information and proposals for Future Agenda Items

a) Flood risk for plant growth in River Darent. Concern has been raised about the build up of plant growth in the Darenth and the potential impact on the Village. Meeting is being arranged between EA, Chevening Estates and Flood Watch team before the next meeting and feedback will be given then

a) **Income Received and Cheques Payable** – to the payments for October were resolved. Cllr Eastwood discussed the financial position for the first half of the Financial year.

It was resolved to repeat our previous Objection to Tandridge Council concerning the development:-

My Parish Council, Chevening, wishes to object to the proposed development of the Moorhouse Tile Works on the grounds of traffic. All vehicles heading for East Kent must pass through the parish. It will increase the severe congestion on the A25 through Bessels Green at peak times, in addition it is well known that queuing on the A25 also impacts on Chipstead village as traffic seeks alternative routes. Chipstead High Street is single file in places and cannot sustain increased flow or large delivery vehicles. Additionally all traffic heading towards Hastings will turn right at the A21/A25 junction which is already one of the top 5 accident blackspots in Kent and increased traffic will only make the situation worse

We wish to ask whether consideration has been given to allowing the Parcel Depot to gain access to and from the M25 at Clackett Lane Services. This would alleviate all congestion through the neighbouring parishes and will allow the vehicles to be streamed into the existing motorway traffic as the service station traffic is now. There is existing access to the hotels on the service station via Clackett Lane
