9. **Height barrier at Recreation Ground** The height barrier at the Recreation Ground is incredibly heavy (we put a stronger & heavier barrier there last year). When you unlatch it, it drops to the ground. Proposal to have a bracket welded onto the horizontal bar so that it stays horizontal and swings rather than crashing to the ground and having to be lifted back up again (to 2.1m in the air). Cost £360
10. **Barbed wire down Sailing Club Road** Complaint from a Parishioner concerning the barbed wire all down Sailing Club Road (much more noticeable as there are no leaves on the undergrowth) both spoiling the appearance of the road and being dangerous
11. **Request for a tree or bench in memorial for former residents** The family of a couple who lived in Woodfields for 40 years would like a bench or tree to commemorate them.
